



Cal Wagner grew up in a large family near Dubuque. Cal worked very hard as a young boy and enlisted in the United States Navy, serving during World War II and Korea. Cal then started his long and distinguished career in Law Enforcement. He served as a Dubuque County Deputy Sheriff before embarking on a 34-year career with the Iowa Highway Patrol. He was a great fisherman, enjoyed hunting fowl, was a physical fitness advocate, and served on the

Highway Patrol Sharpshooter Team for many years.



# Options:

## UPDATING . . .

## Work to CREATE Employment OPTIONS

Since 1966, **Options of Linn County** has provided day habilitation and prevocational services (sheltered workshop) to people with intellectual and physical disabilities. Options is unique in that it is the only county-funded provider of such services for people with disabilities in Iowa.

Through fierce and passionate advocacy in the 1960s and 1970s, people with disabilities began to come out from the shadows of institutionalization and were integrated back into the light of the community.

Options of Linn County was created to serve these exceptional individuals with day habilitation and job training opportunities. This same movement has created new challenges and opportunities for further integration into the community through competitive employment, instead of sheltered workshops.

The Options Future Planning Task Force was created by the Linn County Board of Supervisors to examine the changes in federal regulations and funding restrictions that could require the closure of the Options sheltered workshop, which affects nearly 100 Options consumers. After a year of study and review, the task force identified three key issues that directly impact its future:

- 1) federal regulations that view sheltered workshops as a restrictive environment that segregates the disabled from the community;
- 2) requirements that employers pay minimum wage to people with disabilities in a sheltered workshop instead of the current subminimum wage, which is based on their ability and productivity; and
- 3) changes in the state's reimbursement rate for Options to far below the cost of providing these services. The task force estimated the funding gap to be several hundred thousand dollars annually.



Furthermore, the Linn County Board of Supervisors cannot, by law, allocate additional dollars into the Mental Health/Disability Services levy to subsidize this gap.

The Options Future Planning Task Force — consisting of family members of Options consumers, disability advocates, disability service providers, Options and Linn County staff — voted unanimously to recommend to the Linn County Board of Supervisors that the sheltered workshop close by June 30, 2016.

This date represents the end of Linn County's fiscal 2016 budget.

The task force also recommended restructuring the day habilitation services provided by Options to comply with new federal regulations requiring more community integrated programming.

The task force recognizes not all Options consumers in the sheltered workshop will be able to find, or work in, competitive employment. For those who cannot, they will be able to work at Options until the closure of the sheltered workshop and can receive day habilitation services following the closure.

Linn County case managers will work with Options' consumers and family members to assist them during this transitional period.

The closing of the Options sheltered workshop is not the outcome many had hoped for. However, it is the only feasible alternative available at this time.

I am working closely with area employers to educate them on the benefits of hiring someone with a disability. It can improve a company's culture, bottom line and the social good.

It will take a collaborative effort among family members of Options consumers, disability advocates, Linn County, the private sector and the greater community to make sure the disabled have every opportunity for inclusion and employment.

This truly will take a village.

# Medicaid... A Promise to Keep

**A** number of years ago the state of Iowa made a commitment to reshape the manner in which support services are delivered to people with mental health or developmental disability related service needs. Legislative action was enacted, rules were written, stakeholder input was solicited, and numerous task force meetings were held in 2012 and 2013. Effective July 1, 2014, the state of Iowa had reshaped mental health and developmental disability (MH/DD) service delivery from a county managed system to a regional service delivery model. Ultimately, Iowa's 99 counties formed 15 regions. Ideally, this restructuring would result in more uniform service access and delivery across the state.



While the regional system is still a work in progress, there was another key component of the system redesign that involved the state of Iowa assuming fiscal responsibility for the non-federal share of Medicaid funded services. The idea was that the state could collect needed revenues and administer [Iowa Medicaid](#), while the regions were left to focus primarily on service delivery and funding for services not covered under the Medicaid umbrella. Assurances were made by state leaders that those who rely on Medicaid would not see their services reduced or eliminated due to this initiative but, rather, service access would improve under the new system.

Medicaid funding is based on the economic well being of each state and the [Federal Medical Assistance Percentage \(FMAP\)](#) increases or decreases in accordance with the current state fiscal environment. The good

news is that Iowa fared better than many other states during the recent recession. The bad news is that Iowa's share of federal funds (FMAP) has decreased each of the last several years, creating a significant funding gap for Medicaid services. In short, having fared better than most states during the recent recession has resulted in the federal government funding a smaller percentage of Iowa Medicaid expenses each of the past several years. Since Fiscal Year 2012, Iowa's Federal Medical Assistance Percentage has decreased over 7%, resulting in the shifting of responsibility to pay for millions in Medicaid expenses from the federal government to the state of Iowa. In Fiscal Year 2016 alone, further reductions in federal funding are projected to result in a \$56.1 million Medicaid shortfall in Iowa.

My employer, [Discovery Living, Inc.](#), is a local, non-profit provider of community based residential supports to over 150 people with intellectual disabilities in the greater Cedar Rapids area. Medicaid is the primary source of funding for virtually every person we support. On a state level, Medicaid is expected to be accessed by over 800,000 Iowans in 2016.

Clearly, a program the size and scope of Medicaid needs to be carefully monitored to ensure that Medicaid funds are utilized for their intended purposes. It is also important to remember that reductions in federal funding, which state leaders anticipated, should not be used as an excuse to compromise services for those who need them. As the state budget is prepared, I hope our political leaders remember the commitment they made to their fellow Iowans and fully fund Medicaid.
